AN ORDINANCE APPROVING THE FINAL REVISION OF THE FISCAL YEAR 2021 BUDGET OF THE PARISH OF ST. JAMES, STATE OF LOUISIANA

WHEREAS, the St. James Parish Home Rule Charter provides for amendments to the annual budget; and,

WHEREAS, more specifically, Article V, Section F-4 provides that transfers of appropriation among departments be approved by the Parish Council; therefore,
