**NOTICE IS HEREBY GIVEN** that the following entitled ordinance was introduced at a regular meeting of the Parish Council of the Parish of St. James, State of Louisiana, on November 22, 2022, and laid over for publication of notice:

### **PROPOSED ORDINANCE 22-15 ST. JAMES PARISH COUNCIL**

#### **AN ORDINANCE APPROVING THE FINAL REVISION OF THE FISCAL YEAR 2022 BUDGET OF THE PARISH OF ST. JAMES, STATE OF LOUISIANA**

WHEREAS, the St. James Parish Home Rule Charter provides for amendments to the annual budget; and,

WHEREAS, more specifically, Article V, Section F-4 provides that transfers of appropriation among departments be approved by the Parish Council; therefore,

THE ST. JAMES PARISH COUNCIL HEREBY ORDAINS:
