PUBLIC NOTICE NOTICE OF PUBLIC HEARING

NOTICE IS HEREBY GIVEN that the following entitled ordinance was introduced at a regular meeting of the Parish Council of the Parish of St. James, State of Louisiana, on March 20, 2024, and laid over for publication of notice:

PROPOSED ORDINANCE 24-05 ST. JAMES PARISH COUNCIL

AN ORDINANCE DESIGNATING LEGION STREET, LEGION LANE, AND BURNSIDE STREET AS ONE-WAY STREETS

WHEREAS, the present width of Legion Street, Legion Lane, and Burnside Street do not allow for the uncongested, safe transfer of traffic into and out of these streets; and,

WHEREAS, residents and motorists using these streets would be better served and less likely to be involved in an accident if a one-way designation were imposed on these streets.

WHEREAS, Legion Street will become a once-way street, for entering. Legion Lane will become a one-way street to access Burnside Street. Burnside Street will become a one-way street, for exiting.

NOW, THEREFORE, THE ST. JAMES PARISH COUNCIL HEREBY ORDAINS that Legion Street, a public street owned and maintained by St. James Parish, be and is hereby designated as a one-way street.

BE IT FUTHER ORDAINED BY THE ST. JAMES PARISH COUNCIL that Legion Street will be legally posted as a one-way street and violators will be subject to such fines and penalties as provided in the St. James Parish Code of Ordinances.

NOTICE IS HEREBY, FURTHER, GIVEN that the Parish Council of said Parish will meet at 6:00 p.m. on Wednesday, April 3, 2024, in the Council Chambers of the Parish Courthouse, 5800 Hwy 44, Convent, LA at which time there will be a public hearing on the adoption of the aforesaid ordinance.
