NOTICE IS HEREBY GIVEN that the following entitled ordinance was introduced at a regular meeting of the Parish Council of the Parish of St. James, State of Louisiana, on November 20, 2024, and laid over for publication of notice:

PROPOSED ORDINANCE NO. 24-25 ST. JAMES PARISH COUNCIL

AN ORDINANCE ADOPTING THE ANNUAL BUDGET OF REVENUES AND EXPENDITURES FOR THE FISCAL YEAR JANUARY 1, 2025, TO DECEMBER 31, 2025, PARISH OF ST. JAMES, STATE OF LOUISIANA

THE ST. JAMES PARISH COUNCIL HEREBY ORDAINS that:

SECTION I. The estimate of revenues as reflected in the attached consolidated statement, and such other fiscal exhibits and information as required by Section 1308(D), Louisiana Local Government Budget Act, be and the same is hereby adopted to serve as the Budget of Revenues for the Parish of St. James, State of Louisiana, for the Fiscal Year January 1, 2025, to December 31, 2025.

SECTION II. The estimate of expenditures as reflected in the attached consolidated statement, and such other fiscal exhibits and information as required by Section 1308(D), Louisiana Local Government Budget Act, be and the same is hereby adopted to serve as the Budget of Expenditures for the Parish of St. James, State of Louisiana, for the Fiscal Year January 1, 2025, to December 31, 2025.

SECTION III. The adoption of the Budget of Expenditures as reflected in the line-item budget containing account object of expenditure classifications shall be declared to be the appropriation of the amounts set therein as established in each budget classification by object of expenditure.

SECTION IV. The amounts appropriated for all accounts shall not exceed the amounts fixed therefore in the Budget of Expenditures. Nothing contained in this section shall be construed to prohibit the governing authority from amending or making an appropriation to and for a contingency fund to be used in cases of emergency.
