AN ORDINANCE APPROVING A COMMERCIAL LEASE AGREEMENT BETWEEN CONSTRUCTION MAINTENANCE, INC. AND ST. JAMES PARISH GOVERNMENT FOR THE CONTINUED OPERATION OF THE ST. JAMES PARISH FLEET MAINTENANCE DIVISION AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE, AND ADMINISTER SAID LEASE AGREEMENT AND ANY AND ALL RELEVANT DOCUMENTS

WHEREAS, Construction Maintenance, Inc. is the owner of the commercial property located at 1215 S. David St., Lutcher, LA 70071; and,

WHEREAS, Construction Maintenance, Inc. and St. James Parish Government wish to enter into a commercial lease agreement for the operation of the St. James Parish Fleet Maintenance Division at the property located at 1215 S. David St., Lutcher, LA 70071; and,

WHEREAS, Construction at the fleet maintenance facility in Convent, LA has hindered fleet maintenance functions; and,

WHEREAS, St. James Parish has developed a commercial lease agreement between Construction Maintenance, Inc. for the purpose as expressed herein.

NOW, THEREFORE, BE IT ORDAINED, by St. James Parish Council, that Parish President Peter Dufresne is hereby duly authorized and empowered, on behalf of the St. James Parish Council, to sign a commercial lease agreement between Construction Maintenance, Inc. and the Parish for the operation of the Fleet Maintenance Division at the property located at 1215 S. David St., Lutcher, LA 70071.
