### **PROPOSED ORDINANCE NO. 20-10** **ST. JAMES PARISH COUNCIL**

#### **AN ORDINANCE APPROVING THE FINAL REVISION OF THE FISCAL YEAR 2020 BUDGET OF THE PARISH OF ST. JAMES, STATE OF LOUISIANA**

WHEREAS, the St. James Parish Home Rule Charter provides for amendments to the annual budget; and,

WHEREAS, more specifically, Article V, Section F-4 provides that transfers of appropriation among departments be approved by the Parish Council; therefore,

THE ST. JAMES PARISH COUNCIL HEREBY ORDAINS:
