**NOTICE IS HEREBY GIVEN** that the following entitled ordinance was introduced at a regular meeting of the Parish Council of the Parish of St. James, State of Louisiana, on May 26, 2021, and laid over for publication of notice:

### **PROPOSED ORDINANCE 21-07 ST. JAMES PARISH COUNCIL**

#### **AN ORDINANCE AUTHORIZING ADMINISTRATION TO PAY CERTAIN ACCOUNTS PAYABLE INVOICES PRIOR TO COUNCIL APPROVAL**

WHEREAS, administration currently disburses and pays accounts payable invoices after council approval and,

WHEREAS, administration seeks to make certain payments under certain conditions prior to approval by the council,

NOW, THEREFORE, THE ST. JAMES PARISH COUNCIL HEREBY ORDAINS:

SECTION 1. The council authorizes administration to pay invoices for telecommunications, electricity, gas and water upon receipt.

SECTION 2. BE IT FURTHER ORDAINED by the St James Council that the council authorizes administration to pay a vendor, previously approved by the council for payment where the accounts payable check was lost, immediately upon issuance of a stop payment order as long as the duplicate check is to the same vendor, for the same amount, and for the same invoice.

SECTION 3. BE IT FURTHER ORDAINED by the St. James Parish Council that all payments made by this ordinance will placed on the council meeting agenda for approval by the council.

**NOTICE IS HEREBY, FURTHER, GIVEN** that the Parish Council of said Parish will meet at 6:00 p.m. on Wednesday, June 9, 2021, in the Council Chambers of the Parish Courthouse, 5800 Hwy 44 in Convent, LA at which time there will be a public hearing on the adoption of the aforesaid ordinance.
